- The Bidder must enclose (alongwith their Bids) the EMD/Bid Security of the requisite amount, in the shape of Demand Draft payable to "ICAR Unit, ICAR-RCER, Patna", payable at Patna. The sealed bid must reach the Assistant Administrative Officer, Research Centre for Makhana, Basudeopur Farm, Near Delhi More, Darbhanga- 846005 on or before the last date and hour for submission of bids. Late Auction-Bids (i.e. Bids received after the last date and hour of receipt) shall not be considered.
- The interested Auction-Purchase-Bidders should fill up the Auction-Purchase-Bid Form in the prescribed format (uploaded on our Website) and enclose the necessary EMD/Bid Security, alongwith a Self-attested copy of Identity-proof and a Self-attested Passport-size Photograph, in a sealed envelope.
- The Auction-Purchase-bid of the highest acceptable responsive Bidder will be accepted, subject to such highest Bid Price being equal to or more than the Reserved Price of the condemned vehicle. If the price offered by the highest bidder for any vehicle is less than the Reserve price, the negotiation may be held only with that Bidder for that vehicle, in order to fetch at least the Reserve price.
- The successful Auction-Purchase-Bidder must deposit full payment (i.e. residual amount after adjusting the EMD/Bid Security) within next two working days and must lift/take over the condemned vehicle within four working days from the Bid-opening date, otherwise the EMD/Bid Security shall be forfeited and other actions including re-sale of the condemned vehicle will be initiated at the risk and cost of the defaulter.
