
Memorandum

Based on the recommendation of the selection committee held on 11.05.2016 at this Complex, the Director, ICAR Research Complex for Eastern Region, Patna is pleased to offer an engagement as field Assistant to **Sh. Omkar Kumar S/o Sh. Surendra Prasad Singh** at ICAR-RCER, Patna purely on contractual basis in the project "Improving Water use for dry season agriculture by marginal and tenant farmers in the eastern Gangatic Plains" at ICAR Research Complex for Eastern Region, Patna, under the following terms & conditions:-

1. The position is purely on contractual basis. The position does not entitle any claims for any ICAR Post and he will be engaged up to August, 2018 or termination of the project further order whichever is the earliest.
2. The above temporary engagement will not confer any right on him for regular appointment.
3. The monthly remuneration admissible to him will be ₹10,000/- (Rupees Ten Thousand Only fixed) per month.
4. His place of posting will be project area i.e. Mauahi or Bhagwatipur villages in the Andhrathadi block of Madhubani district in Bihar/any other place on need based, to be decided by the Competent Authority.
5. Since the engagement is purely on contractual basis, his present position may be terminated with a notice of one month from either side. The payment of the notice period to be borne by party/side issuing the notice. If the candidate fails to follow the procedure, he will have to deposit one month payment immediately prior to acceptance of his resignation.
6. He should produce two character certificates from Gazetted officers of Central/State Government.
7. His appointment will be subject to the condition that he is declared medically fit for the service by the District Civil Surgeon or other appropriate Medical authority.
8. He should bring with him the original certificates for verification of his date of birth and educational qualifications along with one set of attested copies of those certificates.
9. He is entitled to avail 8 (Eight) days casual leave per annum and any other holiday (s) announced by this office for regular employees.
10. He will devote his whole time to the assignments given to him and will not be allowed to hold any another appointment paid or otherwise during this tenure.

11. He will be governed by the disciplinary regulations of the host institute where he is working.
12. He will not be entitled for the benefits of General Provident Fund or any other financial benefits extended by ICAR to its employees.
13. Other conditions of service will be governed by the relevant rules and orders issued from time to time.
14. If any declaration given or information furnished by him proves to be false or he is found to have willfully suppressed any material information, he will be liable to be removed from service.
15. The PI/ Co-PI concerned Scientists of the said project will be the supervisory officer of the Project Assistant for all purposes while the Director will be the overall controlling officer.
16. He shall submit a detailed consolidated report of the work done during the period of his engagement.

In case **Sh. Omkar Kumar**, accepts the above terms and conditions, he should submit his acceptance to the office immediately and join the offered post within 15 days from the date of receipt of this offer, failing which this offer will be stand withdrawn/cancelled automatically and no correspondence in this regard will be entertained.
