CORRIGENDUM

This is in reference to ASRB's notice of even no. dated 21<sup>st</sup> July, 2017 wherein all the applicants, who already submitted their applications for the post of LDC, in response to the individual advertisements issued by various ICAR Institutes, were requested to visit the websites of ASRB/ICAR viz. [www.asrb.org.in/](http://www.asrb.org.in/) [www.icar.org.in](http://www.icar.org.in) and submit their particulars in the application format available online on the given link, during the period from 28/07/2017 (9.00A.M.) to 17/08/2017 (5.00P.M.). Now, the last date for furnishing of particulars has been extended up to 04/09/2017 (Monday), 5.00P.M. The date of examination (i.e. 10<sup>th</sup> September, 2017 fixed earlier) has also been re-scheduled and the examination shall now be held on the 28<sup>th</sup> October, 2017 tentatively. Time schedule for the same shall be notified separately, in due course. The applicants who have not yet submitted their particulars in the online format, may now do so. It is also reiterated that call letter for the exam shall be issued to only such candidates who register their particulars on the given link by 04.09.2017. Those who fail to register their personal details online on the aforesaid link by the extended date i.e. by 04/09/2017(5.00 P.M.), will not be allowed to appear in the examination under any circumstances, even if he/she had submitted a valid application for this post earlier.
