## OFFICE ORDER

Sub.: Preventive measures to contain the spread of COVID-19-reg.

In pursuance of the Para Nos. 2, 8 & 9 of the Order No. dated 30.07.2020 issued by the Special Secretary, Home Department, Government of Bihar, Patna, based on the review of the prevailing situation of COVID-19 positive cases throughout the entire State of Bihar \_ and in accordance with the Para No. 5 of MHA Order No. 40-3/2020-DM-I(A) dated 29.07.2020 (duly endorsed vide ICAR No. GAC-21-24/2020-CDN dated 31.07.2020) \_ the Competent Authority of this Research Complex has accordingly taken the following decisions:-

- 1) The ICAR-RCER Headquarter, Patna, the Research Centre for Makhana, Darbhanga and KVK, Buxar, all lying in the State of Bihar, shall continue working from 01.08.2020 to 16.08.2020 with 50% of its strength. However, the essential services related to all the three Campuses, the Division of Livestock & Fisheries Management, the essential experiments of the Division of Crop Research/Farm activities the Security Section and the Estate Management Unit shall continue uninterrupted with the support of the staff / officers on need basis.
- 2) All the HoDs shall attend the office on every working day, during the aforementioned Lockdown period (August 1-16, 2020), in order to monitor the experiments & Divisional activities and to respond to any queries of the Council. They shall be required to prepare Divisional Rosters, ensuring that the guideline for 50% physical presence of the strength is followed. Similar exercise has to be completed by all Section(s) -in -charge / In-charge of Cells, etc.
- 3) The employees working in the Sections of Purchase & Stores, Audit & Accounts and Cash & Bill shall attend office, in order to perform the essential duties pertaining to their respective sections, subject to the limitation of 50% of staff strength.
- **4)** Further, all such employees, who may be living in any of the Containment Zones, or who may be having any of the co-morbidities e.g. hypertension, diabetes, asthma, heart aliments, kidney aliments, etc., or who may have come into contact of any COVID-positive persons, should avoid to physically attend office, and instead stay back at home and ensure to work from home to the maximum possible extent.

- 5) The remaining employees/officers of ICAR-RCER Headquarters, Patna, RCM, Darbhanga and KVK, Buxar would henceforth be required to work from home, to the extent possible, during the ongoing Lockdown period from 01.08.2020 to 16.08.2020; however, they must remain prepared to be called (through telephone/Mobile/email/WhatsApp/ messenger/Institute Vehicle, etc.), to physically attend to any urgent and essential duties in office, beyond their roster-duty, as and when necessary in public interest.
- **6)** The **aforesaid decisions** are **applicable**, only in respect of **ICAR-RCER Headquarter**, **Patna**, **RCM**, **Darbhanga** and **KVK**, **Buxar**.
