### MOST URGENT NOTICE

#### RE-EXAMINATION FOR TECHNICIAN (T-1) IN ICAR

The kind attention of all such candidates, who applied for the posts of Technician (in T-1 grade) at the ICAR – Research Complex for Eastern Region (ICAR-RCER), Patna, and subsequently appeared at the common All-India-level examination (using OMR sheets) conducted by the Agricultural Scientists Recruitment Board (ASRB), New Delhi, on the O4th September, 2016, is drawn to the recent ASRB Notices (copies enclosed), vide which the aforesaid examination stands cancelled, owing to certain confidential administrative reasons.

Accordingly, the **re-examination**, through **computer-based online mode**, will now be conducted on the **24**<sup>th</sup> **June**, **2018** (**Sunday**) at various examination centres across the country.

Only those candidates, who appeared at the earlier examination, held on 04.09.2016, will be eligible to appear at the re-examination. They are required to visit the websites of ASRB/ICAR viz www.asrb.org.in/www.icar.org.in and submit their particulars in the application format available online on the given link during the period from 16.04.2018 (9:00 A.M.) to 15.05.2018 (5:00 P.M.). The said link will be disabled after 5:00 P.M. on 15.05.2018. Registration after 5:00 P.M. on 15.05.2018 will not be allowed under any circumstances. The Institute/ICAR/ASRB will, thereafter not consider any request from any applicant for appearing in the re-examination, after the closing date of registration.

While submitting particulars online, the applicants will have to choose examination centres out of the given options. However, the Board (i.e. **ASRB**) reserves it's right to change/alter the examination centre opted by an applicant, at it's discretion for operational reasons, and no correspondence for change/alteration in the examination centre shall be entertained.

Separate letters are also issued to the individual applicants through e-mail and Speed Post, to apprise them of the re-examination on 24.06.2018, owing to the cancellation of examination previously held on 04.09.2016. Detailed instructions regarding the process of examination will be issued separately after the process of online registration is completed.

#### NOTICE

The Agricultural Scientist Recruitment Board (ASRB) has been given the responsibility for conducting a common competitive examination for filling up positions of Technician (T-1) in 38 research institutions of the Indian Council of Agricultural Research (ICAR) as in Appendix-I. The Board had earlier conducted the common examination on the 04<sup>th</sup> September, 2016 in conventional mode (by using OMR sheets) at 27 exam centres located all over the country. However, due to some administrative reasons, this exam has been cancelled and it has been decided that the Board would conduct a common re-examination only for those applicant who had appeared on 04/09/2016, through computer based on-line mode now on 24<sup>th</sup> June, 2018 (Sunday) at various examination centres across the country. All concerned were accordingly informed about this decision through ASRB's notice vide No. 5(60)/2017-CC-II dated 04<sup>th</sup> April, 2018, which was displayed on ASRB/ICAR website <a href="https://www.icar.org.in">www.icar.org.in</a>. For holding online examination, the Board needs to prepare a common data base of all the candidates in online mode.

Therefore, all those applicants, who have already submitted their applications for the post of Technician (T-1) in response to the individual advertisements issued by various ICAR Institutes and had actually appeared in the offline mode (OMR based) examination held on 04/09/2016, are requested to visit the websites of ASRB/ICAR viz. <a href="https://www.asrb.org.in/www.icar.org.in">www.asrb.org.in/www.icar.org.in</a> and submit their particulars in the application format available online on the given link during the period from 16.04.2018 (9.00 A.M) to 15.05.2018 (5.00 P.M.). The said link will be disabled after 5.00 P.M. on 15.05.2018. Registration after 5.00 P.M. on 15.05.2018 will not be allowed under any circumstances. The Board will not consider any request for appearing in the examination after closing date of registration.

Any applicant who had not appeared in the examination held on 04/09/2016 need not register at this stage, as under no circumstances, such applicant will be considered to appear in this re-examination. Such applicants even if inadvertently appear in this re-examination, shall be treated as ineligible and their candidature shall be rejected summarily, as and when noticed.

While submitting particulars online, the applicants will have to choose examination centres out of the given options. However, the Board reserves it's right to change alter the examination centre opted by an applicant, at it's discretion for operational reasons, and no correspondence for change/alteration in the examination centre shall be entertained.

Further, those who fail to register their personal details on-line on the aforesaid link by the prescribed date, will not be allowed to appear in the examination under any circumstances, even if he/she had submitted a valid application for this post earlier and appeared in the OMR based examination held on 04/09/2018. The applicants need not deposit any fees again.

Detailed instructions regarding the process of examination will be issued separately after the process of online registration is completed.
